1. Welcome & Introductions

2. Minutes (November 22, 2022) Reviewed and Approved.

3. Review of Proposals

Jennifer summarized the next steps: review of proposals, discussion of any other, e.g., non-fee related student feedback or recommendations that could be included in the Chancellor's letter.

1. Community Events (formerly Wellness & Community)

Request: \$70,188

\$0 increase.

Recommendation: None. Mobile app improvements appreciated, better outreach. Cathleen: Will pass along feedback; there is an opt-in channel for community events.

2. Family Services

Request: Permanent \$1,718; increase of \$82 for contact cost.

Temporary: \$25,082; a reduction due to lower minimum contracted uses

for back-up care.

Recommendation: Additional work to look at the issue of subsidies for childcare.

3. Fitness & Recreation (Outdoor Programs)

Request: \$228,997; \$0 increase

Question: Notice no increase, but there is inflation. Are the changes negligible? Jennifer: Historically, units use other sources for salary/other increases. The increase in student service fee comes with mandatory 50% of increase to go to Student Mental Health, so the SHCS unit has had increases. Departments understand that the student services fee doesn't have the capacity to fund increases. Matthew displayed the budget and projections to demonstrate the constraints this committee has on funding.

Recommendation: None

4. GPSA

Request: \$20,247; \$0 increase

The allocation is a passthrough to RCOs as well as systemwide meetings, including

food costs.

Recommendation: None

5. Career & Professional Development

Request: \$514,105; \$0 increase

Recommendation: Would there be a way to get assistance with editing papers, or a resource where students can go added to their website, such as the CLE?

6. Student Health and Counseling Services

Request: \$2,089,300; 2.9% increase (\$59k) to offset increases in salary and benefits.

Recommendation: Reemphasize that staffing issues need to be addressed to meet student needs.

7. Student Life

Request: \$616,477; \$0 increase

Recommendation: Could the department look into the quality of food items available

at student market?

 - a. Subsidized dependent care
 - b. Transportation costs
 - c. SHCS recruitment
